Because of your interest in the Flea Market, you can pre-register for the event, which will be held on **Saturday, June 3, 2017**. THE FLEA MARKET WILL BE HELD RAIN OR SHINE at the future home of the Lisbon Volunteer Fire Company, located at the corner of Route 94 and Route 144.

Set-up: 6:00 am – 8:00 am

Sale: 8:00 am – 1:00 pm

Clean-up: 1:00 pm – 2:00 pm

Spaces are 14' wide by 20' deep. All spaces are assigned on a first-come, first-served basis as contracts and payments are received.

The fee for each space is \$20. You may rent as many spaces as you would like. If you pre-register you will receive a confirmation phone call and a *guaranteed space*. Please be sure to leave enough time for your pre-registration form and payment to make its way to us.

If space is available, registration and payment will be accepted on the day of the Flea Market for \$25 per space.

2. An adult (at least 18 years old) must be present at each vendor site the entire day.
3. Vendors are responsible for all items sold.
4. No items deemed unsafe and/or illegal, as stated by State of Maryland laws, will be sold.
5. All vendors are responsible for any applicable taxes.
6. All items must be contained within the rented space.
7. Vendors are responsible for providing tables, chairs, tents, lighting, etc., for their space.
8. Electricity is not available.
9. No food or beverages are to be sold by vendors unless approved by the Lisbon Volunteer Fire Company.
10. An additional fee of \$31 will be charged for any returned checks.
11. Vendors must remove all items at the end of the flea market or will be charged an additional \$50 fee.
12. Vendors must clear the grounds by 4:00 pm the day of the sale.
13. NO PETS ARE ALLOWED ON THE GROUNDS THE DAY OF THE SALE.
14. Lisbon Volunteer Fire Company is not responsible for accidents or loss of property.
15. Lisbon Volunteer Fire Company reserves the right to refuse admission or eject any vendor or buyer.
